Please find enclosed the Notice of Change of Ownership/Control form for Grand Bay Convalescent Home, Inc., a 92-bed skilled nursing facility located in Grand Bay, Alabama. This notice proposes the change of ownership of the facility from Open Range of Alabama LLC (real property seller) to **Arabella Health & Wellness of Grand Bay PropCo LLC** (proposed CON Holder, real property buyer and new lessor) and the transfer of operational control from Grand Bay Convalescent Home, Inc. (outgoing CON Holder and operator/licensee) to **Arabella Health & Wellness of Grand Bay OpCo LLC** (proposed facility operator/licensee and new lessee). The details of this transaction are outlined in the Purchase and Sale Agreement which will be provided upon request.

Upon approval of the change of ownership by the Alabama Department of Public Health and evidenced by the issuance of a new Nursing Home License, the contemplated transaction will become effective on or after October 1, 2024 (Commencement Date). Arabella Health & Wellness of Grand Bay PropCo LLC (lessor) and Arabella Health & Wellness of Grand Bay OpCo LLC (lessee) will enter into a new lease agreement that will be effective on the Commencement Date.

Part IV: Terms of Purchase - Attachment

- The services provided will be skilled nursing care as offered by the previous operator.
- 2. There will be no new beds added.
- 3. There will be no conversion of beds.
- 4. The proposed transaction will be a sale of assets (real property, personal property, equipment, and operational control). The operations will be transferred from Grand Bay Convalescent Home, Inc. to Arabella Health & Wellness of Grand Bay OpCo LLC. The real estate will be transferred from Open Range of Alabama, LLC to Arabella Health & Wellness of Grand Bay PropCo LLC. There will be a new lease agreement executed between Arabella Health & Wellness of Grand Bay OpCo LLC and Arabella Health & Wellness of Grand Bay PropCo LLC once the sale has occurred.

Note:


Open Range of Alabama, LLC (Current Building Owner/Lessor)
