Please find enclosed a Notice of Change of Ownership form for the home health agency owned and operated by Fayette Medical Center Homecare, LLC d/b/a Fayette Medical Center Homecare (the "Agency"), which has been assigned Facility ID 057-H7088. We are also including before-and-after organization diagrams and confirmation of payment of the \$2,500 CHOW application fee. As indicated on the enclosed diagrams, Adoration Home Health Acquisitions, LLC will be acquiring 67% of the equity of the Agency from current owner Alabama Health Care Group, LLC. The financial scope of the proposed acquisition will encompass the fair market value for the transfer of the stock of the Agency. The proposed acquisition does not involve any new costs associated with the Agency exceeding any of the thresholds set forth in Alabama Code § 22-21-263(a)(2).

In response to the Alabama State Health Planning and Development Agency's ("SHPDA") October 30, 2025 written response to the Notice of Change of Ownership/Control Form (the "Notice"), submitted on behalf of Fayette Medical Center Homecare, LLC d/b/a Fayette Medical Center Homecare (the "Agency"), we are providing additional information regarding our Notice.

Following our further discussion with SHPDA, we are confirming that this transaction is structured as the sale of the equity of the Agency. The CON will remain with the Agency, which will continue to own and operate the home health provider. Accordingly, we have updated Part III of the Notice to clarify the "Name of Entity" and "Operator" fields. We have also updated the "Name of Facility/Provider" in Part I, as requested.

The equity transfer will not impact Clay County Hospital's minority ownership in the Agency, and Clay County Hospital will maintain its representation on the Agency's board.

Please also note that we have updated the "Proposed Date of Transaction" to December 1, 2025.


