The next two projects were postponed from the November 16, 2016 Board meeting:

- A. AL2016-035, Bio-Medical Applications of Alabama, Inc. d/b/a Fresenius Kidney Care Hope Hull, Montgomery, AL:** Proposes to construct and operate a new End Stage Renal Disease Dialysis Treatment Center consisting of twelve (12) in-center hemodialysis stations and one (1) isolation station for a total of thirteen stations. **Opposition: None**
- B. AL2016-036, St. Vincent's Chilton, Clanton, AL:** Proposes to initiate a swing bed program by certifying ten (10) of the thirty (30) acute care beds into the Center for Medicare and Medicaid Services (CMS) Swing Bed Program. **Opposition: None**

AL2016-038, Fresenius Medical Care Birmingham Home, LLC d/b/a Fresenius Medical Care Birmingham, Birmingham, AL:** Proposes to expand the existing ESRD Treatment Center consisting of thirteen (13) home training stations through the addition of four (4) home training stations for a total of seventeen (17) home training stations. **Opposition: None**

D. **AL2017-001, The Harbor at Hickory Hill, Prattville, AL:** Proposes to add sixteen (16) new specialty care assisted living beds through construction of a new addition to the existing thirty-two (32) bed SCALF. **Opposition: None**

AL2016-015, Metro Treatment of Alabama, LP d/b/a Opelika Treatment Center, Opelika, AL: Proposes to replace and relocate the existing opiate replacement treatment facility from 106 Hospital Road, Ste. 101, Livingston, AL, Sumter County to 1051 Fox Run Parkway, Opelika, AL, Lee County, Region III. **Administrative Law Judge submitted Recommended Order dismissing the Contested Case Hearing and remanded the project to the CONRB. Opposition: East Alabama Medical Center**
