These projects have been put on the agenda for **informational purposes only**. No vote is required because "the recommended order of the Administrative Law Judge becomes the final order of the Agency when no exceptions have been filed." No exceptions were filed. The ALJ approved these projects.

AL2017-036, Huntsville Senior Services, LLC d/b/a Regency Remembrances, Huntsville, AL: Proposes to renovate an existing building and add forty-two (42) SCALF beds to an existing seventy-two (72) bed SCALF facility. This is pursuant to a Plan Adjustment to the State Health Plan, rule 410-2-4-.04. **The ALJ awarded fourteen (14) beds.**

AL2017-037, Twenty Two Pack Management Corp., Huntsville, AL: Proposes to convert eighteen (18) existing assisted living beds, located at HarborChase of Huntsville consisting of thirty-eight (38) SCALF beds, to eighteen (18) specialty care assisted living beds. This is pursuant to a Plan Adjustment to the State Health Plan, rule 410-2-4-.04. **The ALJ awarded fourteen (14) beds.**

AL2017-038, Shepherd Living at The Range, LLC, Madison, AL: Proposes to establish a forty-two (42) bed Specialty Care Assisted Living Facility. This is pursuant to a Plan Adjustment to the State Health Plan, rule 410-2-4-.04. **The ALJ awarded fourteen (14) beds.**

Projects A-E were postponed from the January 17, 2018 CONRB meeting

- A. Project Modification (postponed from the December 13, 2017 CONRB meeting)**
AL 2016-022, Geneva County Health Care Authority, Inc., Geneva, AL:
Proposes to acquire, relocate and operate five (5) geriatric psychiatric inpatient beds as an addition to its existing sixteen (16) bed geriatric psychiatric unit. These beds will be relocated from the now closed Chilton Medical Center.
Project Modification Request: Increase in the project cost from \$110,500.00 to \$232,351.13, a result of new management and new architectural firm. **Opposition:** Laurel Oaks opposes any attempt to change the limiting language set out in the original CON.
- B. AL2017-045, Northwest Alabama Cancer Care, LLC, Florence, AL:** Proposes to construct a cancer center adjacent to the new replacement hospital, North Alabama Medical Center, providing medical oncology, infusion therapy, external-beam radiation therapy, stereotactic radiosurgery, brachytherapy, and related support. **Opposition:** Alliance Oncology, LLC, Alliance Oncology of Alabama, LLC, Bethesda Cancer Center, and Valley Cancer Center.
- C. AL2017-046, Nephrology Consultants, LLC d/b/a Nephcon Vascular Access Center, Huntsville, AL:** Proposes to renovate the existing office and operate a single specialty Ambulatory Surgery Center providing vascular access procedures. The ASC will consist of one procedure room, a pre-operative patient holding area, post-anesthesia recovery unit and appropriate support areas. **Opposition: None**
- D. AL2017-047, Nephrology Vascular Lab of Central Alabama ASC, LLC, Birmingham, AL:** Proposes to establish an ambulatory surgery center consisting of two (2) operating rooms providing a full range of vascular access services for dialysis patients. **Opposition: Brookwood Baptist Medical Center filed Notice of Intervention and Opposition.**
- E. AL2017-048, Fresenius Vascular Care Montgomery ASC, LLC, Montgomery, AL:** Proposes to establish an ambulatory surgery center consisting of two (2) operating rooms providing a range of vascular access services for dialysis patients. **Opposition: The Health Care Authority for Baptist Health, an Affiliate of UAB Health System filed Notice of Intervention and Opposition.**
- F. Project Modification**
AL2017-002, East Alabama Medical Center, Opelika, AL: Proposes to relocate the existing cancer center to a new freestanding cancer center at 2501 Village Professional Drive in Opelika, Alabama. This project will involve the replacement of one (1) linear accelerator and the addition of a second linear accelerator at this location.
Project Modification Request: To temporarily locate the second linear accelerator at the hospital until the completion of the freestanding cancer center that was approved through CON 2780-H.

- G. AL2018-002, Gulf Health Hospitals, Inc. d/b/a North Baldwin Infirmiry, Bay Minette, AL:** Proposes to relocate eight (8) psychiatric beds from Mobile Infirmiry Medical Center to the Senior Behavioral Health inpatient geropsychiatric unit at North Baldwin Infirmiry for a total of twenty-three (23) psychiatric beds.
Opposition: None
- H. AL2018-003, Sapphire Community Dialysis, LLC, Montgomery, AL:** Proposes to establish a new End Stage Renal Disease Dialysis Treatment Center consisting of twelve (12) in-center hemodialysis stations and one (1) isolation station.
Opposition: None
- I. Contested Case**
AL2017-030, Doctors Surgery Center of East Alabama, LLC, Auburn, AL: Proposes to establish an Ambulatory Surgery Center consisting of four (4) operating rooms and two (2) procedure rooms. Administrative Law Judge submitted Recommended Order of Denial. **Opposition: East Alabama Medical Center submitted Opposition/Intervention and Request for a Contested Case Hearing. Exceptions were filed by Doctors Surgery Center of East Alabama, LLC on February 7, 2018.**
