The following Declaratory Ruling Requests have been withdrawn by the Petitioners:

### **Declaratory Ruling Request 152:**

Behavioral Health Group ("BHG") submits this Petition for Declaratory Ruling regarding a request for reviewability determination by Highland Health Systems ("HHS"). Petitioner BHG seeks a declaratory ruling that HHS's proposal to offer "Opioid Treatment (methadone)" in Anniston, Alabama, is subject to mandatory CON review.

### **Declaratory Ruling Request 153:**

BayMark Health Services ("BayMark"), submits this Petition for Declaratory Ruling regarding the Letter of Non-reviewability Request ("LNR") filed by Highland Health Systems ("Highland"). BayMark request that the letter of non-reviewability filed by Highland be denied based on the reasons mentioned in BHG's DR request. In addition, BayMark request the CONRB declare ALABAMA CODE (1975) sections 22-21-263(c) and 22-21-265(a) void and unconstitutional as a whole or inapplicable to applicants seeking to offer methadone treatment in Alabama without first obtaining a CON.

#### **Declaratory Ruling Request 154:**

Colonial Management Group, LP ("Colonial") respectfully moves to intervene in Behavioral Health Group's ("BHG") declaratory ruling request ("152") and seeks to have its opposition and request for declaratory ruling consolidated with DR-152. Petitioner Colonial similarly requests that the Board issue a declaratory ruling that Highland Health Systems' ("Highland") proposal to provide "opioid Treatment (methadone)" in Anniston, Alabama is subject to CON review.
