RV2020-024, Alabama Home Health Care Providers, proposes to provide home health services in Etowah, Talladega, Calhoun, Jefferson, Marshall, and Madison counties in Alabama. **Status: Pending**

RV2021-009, The Healthcare Authority of Winfield, Alabama d/b/a Northwest Medical Center, proposes to expand its Emergency Department's capacity from six (6) to ten (10) examination rooms and will be accomplished at a cost that will not exceed current regulatory thresholds for CON review. **Status: Pending**

Declaratory Ruling 157:

The East Alabama Health Care Authority d/b/a East Alabama Medical Center (EAMC), pursuant to Rule 410-1-9-.01 of the Alabama Certificate of Need Program Rules and Regulations, submits this Petition for Declaratory Ruling regarding the Letter of Non-Reviewability issued to John Mitchell, M.D., and The Heart Center Cardiology, P.C., to perform cardiovascular surgical procedures at 2375 Champions Drive in Auburn, Alabama pursuant to the physician’s office exemption. EAMC seeks a declaratory ruling that a Certificate of Need would be required for the cardiovascular surgical procedures to be offered at The Heart Center Cardiology, P.C.
