#### A. CONTESTED CASE:

**AL2022-022, St. Vincent's Birmingham, Pelham, AL:** Proposes to develop a multi-specialty building to include a Freestanding Emergency Department (FED), imaging center, laboratory, and medical office space. **Opposition: BBH SBMC, LLC d/b/a Shelby Baptist Medical Center & Affinity Hospital, LLC d/b/a Grandview Medical Center.** Opposition was filed on 6/30/2022 and 7/1/2022, respectively. A contested case hearing was requested on July 11, 2022. An ALJ was assigned on 7/14/2022. The ALJ's Order was received on 3/10/2023. Exceptions were filed on 3/17/2023.

**B. AL2022-034, Springhill Center for Advanced Medicine, LLC, Mobile, AL:** Proposes to develop a new ambulatory surgery center (ASC) with four (4) operating rooms and four (4) procedure rooms in Mobile County, Alabama. **Opposition: None**

**C. AL2023-001, Mobile IL-AL Operations, LLC d/b/a Harmony at Mobile, Mobile, AL:** Proposes to construct and operate thirty (30) Specialty Care Assisted Living Facility (SCALF) beds as part of a senior housing community to be constructed in Western Mobile, Mobile County, Alabama. **Opposition: None**

**D. AL2023-004, Let's Play Therapy Center, LLC d/b/a Let's Play Therapy Center, Spanish Fort, AL:** Proposes to relocate existing occupational, physical, and speech rehabilitation therapy services to a larger building. **Opposition: None**

E. **AL2023-005, Cullman Regional Medical Center Hartselle Health Park Freestanding Emergency Department, Hartselle, AL:** Proposes to establish and operate a freestanding emergency department (FED) in Hartselle, Morgan County, Alabama. **Opposition: None**

**AL2023-17E, The Board of Trustees of the University of Alabama for the University of Alabama Hospital, Birmingham, AL:** Proposes to expand its existing Emergency Department to immediately address the urgent problem of overcrowding and boarding. **Opposition: None**
