AL2024-035, Crestwood Healthcare, LP d/b/a Crestwood Medical Center, Madison County, AL: Proposes to convert twelve (12) existing acute care beds to twelve (12) inpatient rehabilitation beds on the main campus of Crestwood Medical Center, a one hundred eighty (180) bed acute care hospital in the city of Huntsville, Madison County, Alabama, Region I. **Opposition: North Alabama Shoals Hospital and Encompass Health Rehabilitation Hospital of North Alabama**

AL2024-036, Rehabilitation Hospital of North Alabama, LLC d/b/a Encompass Health Rehabilitation Hospital of North Alabama, Madison County, AL: Proposes to add thirty-three (33) inpatient physical rehabilitation beds to the existing eight-five (85) bed inpatient rehabilitation facility (IRF), for a total of one hundred eighteen (118) rehabilitation beds in the city of Huntsville, Madison County, Alabama, Region I. **Opposition: Crestwood Medical Center and North Alabama Shoals Hospital**

AL2024-037, RCHP-Florence, LLC d/b/a North Alabama Shoals Hospital, Colbert County, AL: Proposes to add seven (7) inpatient physical rehabilitation (IRF) private room beds to the J.W. Sommer Rehabilitation Unit at North Alabama Shoals Hospital in the city of Muscle Shoals, Colbert County, Alabama, Region I. **Opposition:**

Crestwood Medical Center and Encompass Health Rehabilitation Hospital of North Alabama

AL2025-011, ACTS Retirement-Life Communities, Inc. d/b/a OakBridge Terrace Specialty Care Assisted Living Residence at Magnolia Trace, Madison County, AL:** Proposes to convert fourteen (14) existing assisted living facility (ALF) beds to fourteen (14) specialty care assisted living facility (SCALF) beds at the continuing care retirement community in the city of Huntsville, Madison County, Alabama, pursuant to the October 7, 2022 Statistical Update to the *Alabama State Health Plan*. **Opposition: None**

- C. AL2025-012, Water Oak Enterprises, LLC d/b/a Water Oak Villa, Walker County, AL:** Proposes to add eight (8) specialty care assisted living facility (SCALF) beds to the existing sixteen (16) bed SCALF in the city of Jasper, Walker County, Alabama, for a total of twenty-four (24) memory care beds. **Opposition: None**

- D. AL2025-013, Monroe County Health Care Authority d/b/a Monroe County Hospital, Monroe County, AL:** Proposes to convert ten (10) of its existing acute care beds to swing beds as provided under ALA. ADMIN. CODE r. 410-2-4-.09(1) in order to establish a swing bed program as a new service line at the existing hospital in Monroeville, Monroe County, Alabama. **Opposition: None**

- E. Emergency Request:**
AL2025-016E, Alabama Department of Veterans Affairs d/b/a Command Sergeant Major Bennie G. Adkins State Veterans Home, Coffee County, AL: Proposes to remediate, repair, and restore the existing one hundred seventy-four (174) bed skilled nursing facility with approximately fifty (54) of these beds designated for memory care in Enterprise, Coffee County, Alabama. **Opposition: None**

RV2025-038, Advanced Vascular and Wound Care, P.C., proposes to offer vascular and wound care services at the practice's Alabama physician-owned business. **Status: Non-Reviewable**

RV2025-039R, Lakeland Community Hospital, proposes to convert its existing general acute care hospital to a Critical Access Hospital (CAH) to ensure it can continue to serve the citizens of Winston County. **Status: Non-Reviewable**
