#### A. Contested Case:

**AL2024-008, Southern Orthopaedic Surgery Center, LLC, Montgomery County, AL:** Proposes to develop a freestanding, non-hospital based, limited multi-specialty Ambulatory Surgery Center (ASC) specializing in orthopaedics and neurosurgery in the city of Montgomery, Montgomery County, Alabama. Upon completion, the proposed ASC will have six (6) operating rooms (two of which will be shelled out space only), two (2) procedure rooms, nine (9) pre-operative rooms, and fourteen (14) Phase I recovery stations. The applicant will invest in a robotic arm to assist with minimally invasive joint replacement surgery. **Opposition: Jackson Hospital & Clinic, Inc. and Jackson Surgery Center, LLC; Baptist Medical Center South, and Montgomery Surgical Center, LLC. Opposition filed by parties listed 4/5/2024. Request for contested case filed 4/12 and 4/15/2024. ALJ assigned 4/24/2024. ALJs order received 10/31/2024. Exceptions filed 11/7/2024.**

- B. AL2024-019, North Alabama Shoals Hospital, Colbert County, AL:** Proposes to establish a sixteen (16) bed child/adolescent psychiatric unit adding six (6) out of the ten (10) adult psychiatric beds approved under the State Health Plan Adjustment to the existing twenty (20) bed adult behavioral unit in Colbert County. **Opposition: None**

- C. **AL2024-020, Forest Park Group, LLC d/b/a South Haven Surgical Plaza, Jefferson County, AL:** Proposes to own and operate an orthopedic-focused multi-specialty Ambulatory Surgery Center (ASC) with six (6) operating rooms and two (2) procedure rooms in the city of Hoover, Jefferson County, Alabama. Upon completion, the primary focus for the proposed ASC will be orthopedics, pain, plastics, and general surgery with the anticipation to expand specialties. **Opposition: None**
- D. **AL2024-021, ADKM Properties, LLC, Baldwin County, AL:** Proposes to renovate Baldwin House, an existing forty-four (44) bed regular Assisted Living Facility (ALF) into a thirty-five (35) bed Specialty Care Assisted Living Facility (SCALF) in Daphne, Baldwin County, Alabama, pursuant to the October 7, 2022 Statistical Update to the *Alabama State Health Plan*. **Opposition: None**
- E. **AL2024-022, Fresenius Medical Care Foothills, LLC d/b/a Fresenius Kidney Care Foothills Dialysis, Tuscaloosa County, AL:** Proposes to expand the existing End Stage Renal Disease (ESRD) treatment center comprised of ten (10) in-center hemodialysis stations, including one (1) isolation station through the addition of three (3) home training stations, for a total of thirteen (13) stations in the city of Tuscaloosa, Tuscaloosa County. **Opposition: None**
- F. **AL2024-023, Bio-Medical Applications of Alabama, Inc. d/b/a Fresenius Kidney Care Troy, Pike County, AL:** Proposes to expand the existing End Stage Renal Disease (ESRD) treatment center comprised of twenty-one (21) in-center hemodialysis stations, including one (1) isolation station, through the addition of two (2) in-center hemodialysis station, for a total of twenty-three (23) stations in the city of Troy, Pike County, Alabama. **Opposition: None**
- G. **AL2024-026, The Health Care Authority of the City of Huntsville d/b/a Huntsville Hospital, Madison County, AL:** Proposes to add fifty (50) acute care beds, increasing the total licensed bed capacity to nine hundred thirty-one (931) at its existing acute care hospital in Huntsville, Madison County, Alabama pursuant to ALA. ADMIN. CODE r. 410-2-4-.02(5) Bed Availability Assurance of the *2024-2027 Alabama State Health Plan*. **Opposition: None**
- H. **Emergency Request:**  
**AL2024-038E, Baptist Medical Center South, Montgomery County, AL:** Proposes to add thirty (30) treatment areas to its Emergency Department (ED) and to renovate the registration and waiting area to reduce overcrowding. Jackson Hospital filed comments on 10/21/2024. **Opposition: None**

**RV2024-032, Fresenius Medical Care Mobile Area, LLC d/b/a Fresenius Mobile Transitional Care & Home Therapies**, proposes to provide home hemodialysis services to residents on site at the Arabella Health & Wellness of Mobile facility. **Status: Non-Reviewable**

**RV2024-033, St. Vincent's Chilton**, proposes to renovate its existing Emergency Department by building out two existing rooms. **Status: Non-Reviewable**
