AL2024-025, 211-213 Ana Drive Operations, LLC d/b/a Hilltop at Glenwood II, Lauderdale County, AL: Proposes to convert sixteen (16) existing Assisted Living Facility (ALF) beds into sixteen (16) Specialty Care Assisted Living Facility (SCALF) beds in Florence, Lauderdale County, Alabama. Opposition: KnR Properties, LLC
- B. AL2025-001, Fresenius Medical Care McCalla, LLC d/b/a Fresenius Medical Care McCalla, Jefferson County, AL: Proposes to expand its existing End Stage Renal Disease (ESRD) treatment facility consisting of thirteen (13) in-center hemodialysis stations, including one (1) isolation station, through the addition of four (4) in-center hemodialysis stations, for a total of seventeen (17) stations in the city of Bessemer, Jefferson County, Alabama. Opposition: None
- C. AL2025-003, Bio-Medical Applications of Alabama, Inc. d/b/a Fresenius Medical Care Whetstone, Monroe County, AL: Proposes to expand the existing twenty (20) station End Stage Renal Disease (ESRD) treatment facility, which consists of nineteen (19) in-center hemodialysis stations and one (1) home training station, through the addition of one (1) home training station, for a total of twenty-one (21) stations in the city of Monroeville, Monroe County, Alabama. Opposition: None
- D. AL2025-005, Encompass Health Rehabilitation Hospital of Gadsden, Inc., Etowah County, AL: Proposes the addition of five (5) inpatient physical rehabilitation beds to

the existing forty-nine (49) inpatient rehabilitation facility (IRF), for a total of fifty-four (54) rehabilitation beds, in the city of Gadsden, Etowah County, Alabama, Region IV. **Opposition: None**

RV2025-009, Proveer at Heritage Woods Specialty Care Assisted Living Facility, proposes to modify building to convert five (5) existing Assisted Living Facility (ALF) beds into single occupancy Specialty Care Assisted Living Facility (SCALF) beds. **Status:** Non-Reviewable

RV2025-015, The Board of Trustees of the University of Alabama for the University of Alabama Hospital, proposes to install dedicated medical air pumps for the existing hyperbaric chambers in the clinic. Status: Non-Reviewable

RV2025-016, The Board of Trustees of the University of Alabama for the University of Alabama Hospital, proposes to replace the existing infant warmer and procedures lights in Women's and Infant's Center at the University of Alabama Hospital. Status: Non-Reviewable

RV2025-017, Shelby Baptist Medical Center, proposes to upgrade imaging equipment and relocate dialysis services. **Status: Non-Reviewable**
