A. Contested Case:

AL2024-008, Southern Orthopaedic Surgery Center, LLC, Montgomery County, AL: Proposes to develop a freestanding, non-hospital based, limited multi-specialty Ambulatory Surgery Center (ASC) specializing in orthopaedics and neurosurgery in the city of Montgomery, Montgomery County, Alabama. Upon completion, the proposed ASC will have six (6) operating rooms (two of which will be shelled out space only), two (2) procedure rooms, nine (9) pre-operative rooms, and fourteen (14) Phase I recovery stations. The applicant will invest in a robotic arm to assist with minimally invasive joint replacement surgery. **Opposition: Jackson Hospital & Clinic, Inc. and Jackson Surgery Center, LLC; Baptist Medical Center South, and Montgomery Surgical Center, LLC. Opposition filed by parties listed 4/5/2024. Request for contested case filed 4/12 and 4/15/2024. ALJ assigned 4/24/2024. ALJs order received 10/31/2024. Exceptions filed 11/7/2024. Carried over from the 11/20/2024 CONRB Meeting.**

B. AL2024-024, Magnolia Neuro Rehab, LLC, Madison County, AL: Proposes to add physical therapy and speech language pathology to its existing facility, which currently provides occupational therapy services. **Opposition: None**

C. AL2024-027, Ophthalmic Surgical Partners, LLC d/b/a Center for Eye Surgery, Madison County, AL: Proposes to develop, own, and operate a new single-specialty

ophthalmic ambulatory surgery center (ASC) with two (2) operating rooms and one (1) procedure room in the city of Madison, Madison County, Alabama. **Opposition: Huntsville Surgery Center, LLC d/b/a Laser Eye Surgery Center**

- D. AL2024-033, The East Alabama Health Care Authority d/b/a East Alabama Medical Center, Lee County, AL:** Proposes to transfer seventeen (17) inpatient physical rehabilitation beds from EAMC-Lanier, located in Chambers County, to East Alabama Medical Center, located in Lee County; both counties are included in the 2024-2027 *Alabama State Health Plan's* Inpatient Rehabilitation Bed Region V. **Opposition: None**
- E. AL2024-034, The East Alabama Health Care Authority d/b/a East Alabama Medical Center, Lee County, AL:** Proposes to transfer twenty (20) geriatric inpatient psychiatric beds from EAMC-Lanier, located in Chambers County, to East Alabama Medical Center, located in Lee County; both counties are included in the 2024-2027 *Alabama State Health Plan's* Southeast Psychiatric Care Region. **Opposition: None**
- F. AL2025-002, Bio-Medical Applications of Alabama, Inc. d/b/a Fresenius Medical Care Tallassee, Elmore County, AL:** Proposes to expand the existing End Stage Renal Disease (ESRD) treatment center comprised of ten (10) in-center hemodialysis stations, through the addition of two (2) home training stations, in the city of Tallassee, Elmore County, Alabama. **Opposition: None**

AL2024-015, MBDD, LLC, Madison County, AL: Proposes to establish and operate a multi-specialty Ambulatory Surgery Center (ASC), on the campus of Crestwood Medical Center in Huntsville, Alabama. **Opposition: South Huntsville ASC Holdings, LLC d/b/a Sportsmed ASC. Request for Contested Case filed by Sportsmed ASC and the applicant on 7/30/2024. ALJ was assigned 8/8/2024. ALJs recommended order was filed 11/22/2024 approving the project. No exceptions were filed.**

AL2024-018, South Huntsville ASC Holdings, LLC d/b/a Sportsmed Ambulatory Surgery Center, Madison County, AL: Proposes to establish and operate a limited multi-specialty Ambulatory Surgery Center (ASC) that will provide outpatient surgery for orthopedics, neurosurgery, and pain management in Huntsville, Alabama. **Opposition: Crestwood Medical Center. Request for Contested Case filed by Madison Surgery Center on 8/9/2024 and by MBDD, LLC and Crestwood Medical Center on 8/12/2024. ALJ was assigned 8/29/2024. ALJs recommended order was filed 11/22/2024 approving the project. No exceptions were filed.**

RV2024-040, The Board of Trustees of the University of Alabama for the University of Alabama Hospital, proposes to replace the existing PET/CT Imaging System with a new 32cm PET/CT Imaging System (Wallace Tumor PET CT Renovation). **Status: Non-Reviewable**

RV2024-041, The Board of Trustees of the University of Alabama for the University of Alabama Hospital, proposes to initiate and complete the renovation of the 1st floor of UAB Hospital-Highlands to accommodate a provider-based rehabilitation gym. **Status: Non-Reviewable**

RV2024-042, The Board of Trustees of the University of Alabama for the University of Alabama Hospital, proposes to complete an expansion of the triage area located on the third floor of UAB Hospital-Highlands facility. **Status: Non-Reviewable**

RV2025-012R, Atrium Health Floyd Cherokee Medical Center, proposes to renovate existing exercise room and director's office to create an outpatient mammography room and bone density scan (DXA) room with additional space for a waiting area, staff workstations, and dressing rooms. **Status: Pending**

RV2025-013, Southeast Health Medical Center, proposes to relocate its Medicine Shop to the first floor of the facility's Outpatient Building. **Status: Pending**
