A. Project Modification: AL2022-034, Springhill Center for Advanced Medicine, LLC, Mobile County, AL: Proposes to develop a new Ambulatory Surgery Center (ASC) with four (4) operating rooms and four (4) procedure rooms in Mobile County, Alabama. Project modification request filed 10/1/2025.

B. AL2025-014, Houston County Health Care Authority d/b/a Southeast Health Medical Center, Houston County, AL: Proposes to develop and construct an 85,155 square foot tower addition, the renovation and expansion of the existing emergency department (ED), and the addition of thirty-five (35) inpatient beds pursuant to §410-2-4-.02 Acute Care (Hospitals) Bed Availability Assurance at the existing acute care hospital in Dothan, Houston County, Alabama. **Opposition: None**

The next project has been placed on the agenda for informational purposes only. No vote is required as "the recommended order of the Administrative Law Judge becomes the final order of the Agency when no exceptions have been filed." The project was approved, and no exceptions were filed.

Contested Case:

AL2025-010, Woodlands PH Realty LLC d/b/a The Sanctuary at the Woodlands, proposes to add six (6) geriatric psychiatric beds to The Sanctuary at the Woodlands, an existing forty (40) bed psychiatric hospital in Cullman County, Alabama. The additional six (6) beds will bring the total number of geriatric psychiatric beds to twenty-six (26). **Opposition:** Cullman Regional Medical Center. Request for contested case was filed 6/20/2025. ALJ was assigned 7/8/2025. ALJs recommended order was filed 9/15/2025. No exceptions were filed.
