Mr. Bradford Williams briefly explained that the proposed Rural Emergency Hospital conversion language has been made available to the Committee.

The floor was opened for comment.

After comments from Ms. Estep, Ms. Margaret Whatley (Alabama Hospital Association), Mr. Keith Granger, Mr. Gregg Everett, Ms. Marsal, Mr. Colin Luke, and Mr. Carey McRae were made regarding the proposed Rural Emergency Hospital conversion language, discussions were held.

Mr. Washington informed the committee he would take all of the related comments and submissions of alternative language to the Agency under consideration and send the committee copies of any updated versions of the rule. Mr. Washington stated that there would be another meeting of the Hospital Committee in the near future to continue discussions on the proposed changes.

Ms. Marsal reminded the Committee that the next meeting of the Statewide Health Coordinating Council will be held on March 10, 2026.

Having received no further comment, Chairman Washington adjourned the meeting at 2:20 p.m.
